

Guideline for New Investors, who wish to apply for Generation, Distribution or Consolidated Licenses for Providing Electric Power Services in the Kingdom of Cambodia

The Electricity law of the Kingdom of Cambodia, which was promulgated by the Royal KRAM No. NS/RKM/0201/03 of February 2, 2001. The Electricity Law stipulate that no person may operate as an electric power utility or supply electric power services except he/she has performed under and in accordance with the terms of a valid license issued by the Authority. This law aims to:

1. Promote private ownership on the facilities for providing electric power services
2. Establish competition wherever feasible in the electric power sector
3. Establish Electricity Authority of Cambodia for regulating electric power services, granting the right and obligations and penalize if necessary, the suppliers and consumers of electricity in relation to the generation and electricity supply facilities
4. Create favorable conditions for the investments in, and the commercial operation of the electric power industry.

The Electricity Law has provided the right to Electricity Authority of Cambodia (EAC) issuing 8 Types licenses for providing electric power services as follows:

1. Generation License
2. Transmission License
3. Dispatch License
4. Distribution License
5. Bulk Sale License
6. Retail License
7. Subcontract License
8. Consolidate License

New investors who intend to provide electric power services in the Kingdom of Cambodia shall apply for license from EAC, EAC would like to procedures for applying for license as follows:

1 Application for Generation License

Applicant shall submit an Application for Generation License attached with the following documents:

1. Information sheet (Bulletin) for license application - 3 copies
2. Copy of the proof of deposit of the license application fee - 1 copy
3. Documents attached:

a copy of the Power Purchase Agreement signed by the applicant and power Purchaser - copy |

a copy of the no-objection letter of EAC on the contents of Power Purchase Agreement - 1 copy etc.

2 Application for Distribution License

Applicant shall submit an Application for Distribution License attached with the following documents:

1. Information sheet (Bulletin) for license application - 3 copies
2. Copy of the proof of deposit of the license application fee - 1 copy

3. Documents attached:

a copy of the Power Purchase Agreement signed by the applicant and power purchaser - 1 copy

a copy of the no-object letter of EAC on the contents of Power Purchase Agreement 1 copy etc.

3 Application for Consolidated License

Applicant shall submit an Application for Consolidate License attached with the following documents:

4. Information sheet (Bulletin) for license application - 3 copies

5. Copy of the proof of deposit of the license application fee -1 copy

6. Documents attached:

a copy of the Power Purchase Agreement signed by the applicant and power purchaser - 1 copy

a copy of the no-object letter of EAC on the contents of Power Purchase Agreement 1 copy etc.

Application Form for all type of Licenses and Information Sheet above provided in the Procedures for Issuing, Revising, Suspending, Revoking or Denying Licenses and EAC 's office.
