### **CONSOLIDATED LICENSE FOR MRS. SO RINDA**

### **ELECTRICITY AUTHORITY OF CAMBODIA**

- In exercise of the powers conferred by Article 7 and 29 of the Electricity Law promulgated by the Royal Decree NS/RKM/0201/03, dated 02/02/2001.
- In accordance with Authorized Letter of Provincial Department of Industry, Mines and Energy of Kampong Speu N° 101 dated August 29, 2002.
- In accordance with the application for license of MRS. SO RINDA dated June 03, 2004.
- In accordance with the consultation with licensee, concerned parties and public, made from July 22, 2004 to August 27, 2004.
- In accordance with the decision of Electricity Authority of Cambodia's Session No. 40 dated September 15, 2004.

### **DECIDES**

#### **Article 1**

There is hereby granted the **Consolidated License** to **Mrs. SO RINDA** (herein after referred to as "**Licensee**") Sex female Nationality Khmer, Date of Birth 1974, Permanent Address #14EC, Street No.61B, Sangkat Boeung Kok II, Khan Toul Kork, holding Identification Card No. 010229027 dated April 05, 2002, which electric power service provider at Phsar Thnalbort Town, Khum Por Ankrang, Bor Seth District, Kampong Speu Province and Khum Beungtranh, Samrong District, Takeo Province for giving the right to the licensee as follow:

- (a) to continue to generate electricity at Phum Kronhoung, Khum Por Ankrang, Bor Seth District, Kampong Speu Province for the purpose of supply electric power to his distribution systems by generating facilities defined in schedule 2, during the period specified in Article 3 of Part 1, subject to the conditions set out in Part 2 of this License;
- (b) to continue distribute and supply electricity to consumers in the Authorized Distribution Areas defined in Schedule 1, Part 2 of this License, during the period specified in Article 3 of Part 1, subject to the Conditions set out in Part 2 of this License.

#### **Article 2**

The Conditions referred to above license are subject to modification or amendment in accordance with their terms or with Article 7 and 44 of the Electricity Law of the Kingdom of Cambodia. This license hereby granted is further subject to the terms as to revocation specified in Schedule 3 of Part 2 of this License.

**Article 3**

This license shall come into force from the date it is signed, unless revoked earlier in accordance with the conditions of license, the term of license shall be 2 years and may be renewed for further periods and with such modification as required on the application of license.
