- In exercise of the powers conferred by Article 7 and 30 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03 dated 2 February 2001.
- In accordance with License Documents N° 016 LD dated November 22, 2002.
- Refer with the first revision decision on license document of Mr. Ke Kuyhoy N° 021-04-EAC, dated February 13, 2007.
- In accordance with the application for extending distribution area of Mr. Ke Kuyhoy dated December 15, 2006.
- In accordance with the consultation with concerned parties and public, made from January 24, 2007 to February 23, 2007
- In accordance with the decision of Electricity Authority of Cambodia's Session N°102, dated May 23, 2007

DECIDES

Article 1

To revise the License N° 016 LD granted to **Mr. Ke Kuyhoy** by extending the areas along the National Road N° 2 (to Provincial town of Takoe), 1200meters length from border of existing distribution area close to Phsar Kampongchrey Town, Traing and Kohandet District, Takeo Province to allow **Mr. Ke Kuyhoy** to supply electric power to consumers as show in the map in schedule 1.

Article 2

The Schedule 1 of the license N° 016 LD shall be replaced by new Schedule1 attached here with.

Article 3

This decision and attached revised schedule shall be considered as a part of the license documents N° 016 LD.

Article 4

The other contents and conditions of the license document N° 016 LD with its revisions shall remain in force.

Article 5

The decision shall come into force from the date of signing.

Article 6

The licensee shall send this decision to deposit additionally at the places, where the license document N° 016LD has been deposited in order that the deposited license document N° 016LD is in conformity with this decision.

SCHEDULE 1
AUTHORIZED DISTRIBUTION AREAS
AS AMMENDED IN SESSION OF EAC N°102 DATED May 23, 2007

1. The authorized distribution Areas, where **Mr. Ke Kuyhoy** have the right to provide the electricity distribution and supply services are Phsar Kampongchrey Town, Trang and Kohandet District, Takeo Province (See map attached).

2. Under this license, if Mr. **Ke Kuyhoy** intends to request the extension or the additional distribution areas then Mr. **Ke Kuyhoy** shall prepare all necessary documents and submit to EAC in accordance with the EAC's determination. After EAC authorized to extend or to add distribution area, this schedule 1 shall be revised and attached with that authorization.
