DECISION ON THE FOURTH REVISION
OF THE CONSOLIDATED LICENSE DOCUMENT No.019 LD
DATED DECEMBER 12, 2002 FOR MR. TE KOK ENG

ELECTRICITY AUTHORITY OF CAMBODIA

- In exercise of the powers conferred by Article 7 and 35 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03 dated 2 February 2001.
- Refer to the Consolidated License No.019 LD of Mr. TE KOK ENG issued by Electricity Authority of Cambodia on December 12, 2002.
- Refer to the requested letter of Mr. TE KOK ENG for extending his distribution area, dated August 24, 2007.
- In accordance with the consultation with concerned parties and public, made from September 19, 2007 to October 20, 2007.
- In accordance with the decision of Electricity Authority of Cambodia's Session No. 115 dated November 30, 2007.

DECIDES

Article 1

To revise the license document No. 019 LD dated December 12, 2002 granted to **Mr. TE KOK ENG** (herein after referred to as "**Licensee**"), by adding more distribution areas to its existing areas of supply the electric power service at Khum Treal Town, Baray District, Kampong Thom Province (As shown in the attached map No. 019LD-map-Te Kok Eng-Revised-1-2007).

Article 2

The existing schedule 1 of the license document No. 019 LD is replaced by the new revised schedule 1 attached herewith.

Article 3

The other contents and conditions of the license document No. 019 LD shall remain unaltered and in force.

Article 4

This decision and the attached Schedule are the part of license document No. 019 LD.

Article 5

The decision shall come into force from the date of signing.

Article 6

The licensee shall send this decision to deposit additionally at the places, where the license document No. 019 LD has been deposited in order that the deposited license document No. 019 LD is in conformity with this decision.

SCHEDULE 1
AUTHORIZED DISTRIBUTION AREAS
AS AMMENDED IN SESSION OF EAC No. 115 DATED NOVEMBER 30, 2007

1. The authorized distribution Areas, where the licensee has the right to provide the electricity distribution and supply services are Khum Treal Town, Baray District, Kampong Thom Province.
2. The authorized distribution area is determined by “the boundary maps No. 019LD-map- Te Kok Eng-Revised-1-2007” attached.
3. Under this license, if the licensee intends to request the extension distribution areas then he shall prepare all necessary documents and submit to EAC in accordance with the EAC’s determination. After EAC authorized to extend distribution area, this schedule 1 shall be revised and attached with that authorization.
