- In exercise of the powers conferred by Article 7 and 30 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03 dated 2 February 2001.
- In accordance with License Documents N° 022 LD issued by Electricity Authority of Cambodia on February 11, 2003 to Mr.KONG PHAT
- In accordance with the application for renewing term of license of Mr.KONG PHAT dated December 25, 2006.
- Refer with the first revision decision on license document of Mr. KONGPHAT No.024-05-EAC,dated February 16, 2005
- In accordance with the consultation with concerned parties and public, made from February 22, 2007 to March 09, 2007.
- In accordance with the decision of Electricity Authority of Cambodia's Session N° 102, dated May 23, 2007.

**DECIDES**

**Article 1**

As Mr.KONG PHAT has improved some part of his facilities and he has to improve further in coming years to meet General Requirements of Electric Power Technical standard of the Kingdom of Cambodia, EAC decides to revise license N°022 LD dated February 11, 2003 granted to Mr. KONG PHAT for providing electric power generation and distribution services at Phum Thmarsor,Khum Korkpor,Boreychuolsar District, Takeo Province by renewing the term of license for 3 years.

**Article 2**

The new term of the license shall be 03(Three) years from the date February 11, 2007 and can be renewed for further periods unless revoked earlier in accordance with the conditions of license.

**Article 3**

This decision shall form the part of license N° 022 LD.

**Article 4**

The other contents and conditions of the license document N° 022 LD with its revisions shall remain in force.

**Article 5**

The decision shall come into force from the date of signing.

**Article 6**

The licensee shall send this decision to deposit additionally at the places, where the license document N°022 LD has been deposited in order that the deposited license document N° 022 LD is in conformity with this decision.
