DECISION ON THE SECOND REVISION
OF THE CONSOLIDATED LICENSE DOCUMENT No. 036 LD
DATED APRIL 09, 2003 FOR MRS. PAUCH KIM

ELECTRICITY AUTHORITY OF CAMBODIA

- In exercise of the powers conferred by Article 7 and 35 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03 dated 2 February 2001.
- Refer to the Consolidated License No.036 LD issued by Electricity Authority of Cambodia on April 09, 2003.
- Refer to the requested letter of Mrs. PAUCH KIM for extending his distribution area, dated April 02, 2007.
- In accordance with the consultation with concerned parties and public, made from May 29, 2007 to June 29, 2007.
- In accordance with the decision of Electricity Authority of Cambodia's Session No. 110 dated September 27, 2007

DECIDES

Article 1

To revise the license document No. 036 LD dated April 09, 2003 granted to **Mrs. PAUCH KIM** (herein after referred to as "**Licensee**"), by adding more distribution areas to its existing areas of supply the electric power service at Kar-Andoeuk Town, Khum Brasath, Kampong Trabek District, Prey Veng Province (As shown in the attached map No. 036LD-map-Pauch Kim-Rev2-2007).

Article 2

The existing schedule 1 of the license document No. 036 LD is replaced by the new revised schedule 1 attached herewith.

Article 3

This decision and the attached Schedule are the part of license document No. 036 LD.

Article 4

The other contents and conditions of the license document No. 036 LD shall remain unaltered and in force.

Article 5

The decision shall come into force from the date of signing.

Article 6

The licensee shall send this decision to deposit additionally at the places, where the license document No. 036 LD has been deposited in order that the deposited license document No. 036 LD is in conformity with this decision.

SCHEDULE 1
AUTHORIZED DISTRIBUTION AREAS
AS AMMENDED IN SESSION OF EAC No. 110 DATED SEPTEMBER 27, 2007

1. The authorizes distribution Areas, where the licensee have the right to provide the electricity distribution and supply services is Kar-Andoeuk Town, Khum Brasath, Kampong Trabek District, Prey Veng Province .
2. The authorized distribution area is determined by “the boundary maps No. “036LD-map-Pauch Kim-Rev2-2007” attached.
3. Under this license, if the licensee intends to request the extension distribution areas then he shall prepare all necessary documents and submit to EAC in accordance with the EAC’s determination. After EAC authorized to extend distribution area, this schedule 1 shall be revised and attached with that authorization.
