DECISION ON FIRST REVISION OF THE LICENSE No. 059 LD DATED OCTOBER 07, 2003 TO ELECTRICITY OF KRATIE PROVINCE

ELECTRICITY AUTHORITY OF CAMBODIA

- In exercise of the powers conferred by Article 7 and 35 of the Electricity Law promulgated by the Royal Decree NS/RKM/0201/03, dated 02/02/2001
- Refer to Consolidated License Documents of Electricity of Kratie Province No. 059 LD dated October 07, 2003
- In accordance with the application for license revision of Electricity of Kratie Province No. 02 dated March 24, 2005
- In accordance with the Power Purchase Agreement (PPA) signed between ELECTRICITÉ DU CAMBODGE and ELECTRICITY OF KRATIE PROVINCE dated April 04, 2005
- In accordance with the consultation with concerned parties and public, made from April 26, 2005 to May 27, 2005.
- In accordance with the decision of Electricity Authority of Cambodia's Session No. 53, dated June 30, 2005

DECIDES

To issue revised decision on the license document No. 059 LD granted to ELECTRICITY OF KRATIE PROVINCE on October 07, 2003 (herein after referred to as "**Licensee**") as stated below:

Article 1

To add a distribution area of Snuol District, Kratie Province to ELECTRICITY OF KRATIE PROVINCE, by purchasing electricity from Vietnam under the Power Purchase Agreement (PPA) signed between ELECTRICITÉ DU CAMBODGE and ELECTRICITY OF KRATIE PROVINCE dated April 04, 2005 (As shown in the attached map).

Article 2

Schedule 1 of license No. 059 LD shall be replaced by revised Schedule 1 attached here with.

Article 3

This decision and the attached Schedules are the part of license No. 059 LD.

Article 4

The other contents and conditions of the license No. 059 LD shall remain unaltered and in force.

Article 5

The decision shall come into force from the date of signing.

Article 6

The licensee shall send this decision to deposit additionally at the places, where the license document No. 059 LD has been deposited in order that the deposited license document No. 059 LD is in conformity with this decision.

SCHEDULE 1
AUTHORIZED DISTRIBUTION AREAS
AS AMMENDED IN SESSION OF EAC No. 53 DATED JUNE 30, 2005

1. The authorizes distribution Areas, where ELECTRICITY OF KRATIE PROVINCE has the right to provide the electricity distribution and supply services are the Provincial Town of Kratie and part of Snuol District, Kratie Province (As shown in the attached map)..
2. Under this license, if ELECTRICITY OF KRATIE PROVINCE intends to request the extension or the additional distribution areas then ELECTRICITY OF KRATIE PROVINCE shall prepare all necessary documents and submit to EAC in accordance with the EAC's determination. After EAC authorized to extend or to add distribution area, this schedule 1 shall be revised and attached with that authorization.
