**DECISION ON TERMINATION OF THE RIGHT FOR PROVIDING  
ELECTRIC POWER GENERATION AND DISTRIBUTION SERVICES  
AT ODDOR MEANCHEY  
PROVINCIAL TOWN UNDER THE CONSOLIDATED LICENSE  
No. 092 LD DATED MARCH 16, 2004 ISSUED TO MR. SOM VISAL**

**ELECTRICITY AUTHORITY OF CAMBODIA**

- In exercise of the powers conferred by Article 7 and 30 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03, dated 02/02/2001
- In accordance with Consolidated License Document of Mr. Som Visal No. 092 LD dated March 16, 2004
- In accordance with the letter of Ministry of Industry Mine and Energy No. 0271 dated April 26, 2005
- In accordance with the Contract of Right Transfer made between Mr. Som Visal and Duty Free Shop Co., Ltd dated August 08, 2005
- In accordance with the requested letter for changing the licensee of Mr. Som Visal dated August 08, 2005
- In accordance with the decision of Electricity Authority of Cambodia's Session No.94 dated February 14, 2007

**DECIDES**

**Article 1**

To revoke the right for providing electric power generation and distribution services at Oddor Meanchey provincial town under the consolidated license No. 092 ld dated march 16, 2004 issued to Mr. Som Visal. Mr. Som Visal has requested to EAC to terminate his license and to transfer the above rights to Duty Free Shop Co., Ltd located at Phum Cham Yeam, Khum Pak Klong, Mondul Seyma District, Koh Kong Province and registered in the Kingdom of Cambodia under No. Inv-706/00 P dated August 14, 2000 (pursuant to the Commercial and Civil Law). The reason for the request is that he is unable to invest for construction of the network to avail the power at cheaper tariffs imported from Thailand. Duty Free Shop Co., Ltd has agreed to construct the required network and supply power at Oddor Meanchey provincial town. EAC Accepts the reason and allows Mr. Som Visal to terminate the license and transfer the right to Duty Free Shop Co., Ltd.

**Article 2**

Mr. Som Visal shall have no right to provide the electric power services at Oddor Meanchey provincial town as stated in the consolidated license No. 092 ld dated march 16, 2004 from the date Mr. Som Visal actually transfers the business of supply of electricity at Oddor Meanchey provincial town to Duty Free Shop Co., Ltd. Mr. Som Visal shall submit a copy of the contract of transfer of business executed with Duty Free Shop Co., Ltd to EAC for approval.

**Article 3**

The decision shall come into force from the date of actual transfer of business after approval of contract by EAC.

**Article 4**

The EAC shall send this decision to deposit additionally at the places, where the license document No .092 LD has been deposited in order that the earlier deposited license document No .092LD is no more valid as per this decision.
