- In exercise of the powers conferred by Article 7 and 30 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03 dated 2 February 2001.
- In accordance with License Documents No. 112 LD issued by Electricity Authority of Cambodia on February 16, 2005 to Mr. LY KANG.
- In accordance with the application for renewal of term of Mr. LY KANG dated December 15, 2006
- In accordance with the request for renewal of term of Secretariat Office N°004 -07-SO dated January 09, 2007.
- In accordance with the consultation with concerned parties and public, made from January 22 , 2007 to February 22, 2007 .
- In accordance with the decision of Electricity Authority of Cambodia's Session No. 102 dated May 23, 2007

**DECIDES**

**Article 1**

As **Mr. LY KANG** (herein after referred to as "**Licensee**") has improved some part of her facilities and she has to improve further in coming years in accordance with General Requirements of Electric Power Technical Standards of the Kingdom of Cambodia, EAC decides to revise license No. 112 LD dated February 16, 2005 granted to licensee by renewing her next term of license for 5 years.

**Article 2**

The new term of the license shall be 5 years from February 16, 2007 and may be renewed for further periods unless revoked earlier in accordance with the conditions of license.

**Article 3**

This decision is the part of license of the license document No. 112 LD.

**Article 4**

The other contents and conditions of the license document No. 112 LD shall remain in force.

**Article 5**

The decision shall come into force from the date of signing.

**Article 6**

The licensee shall send this decision to deposit additionally at the places, where the license document No. 112 LD has been deposited in order that the deposited license document No. 112 LD is in conformity with this decision.
