DECISION ON THIRD REVISION
To the License Document N° 101 LD dated September 15, 2004
With second revision N° 101-06-EAC dated October 26, 2006
For MR. CHHIN SONG

ELECTRICITY AUTHORITY OF CAMBODIA

- In exercise of the powers conferred by Article 7 and 35 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03, dated 02/02/2001.
- In accordance with License Documents N° 101 LD dated September 15, 2004.
- In accordance with the application for extending distribution area of Mr. Chhin Song dated December 19, 2006.
- In accordance with the consultation with concerned parties and public, made from December 24, 2007 to January 30, 2008
- In accordance with the decision of Electricity Authority of Cambodia's Session N°123, dated February 15, 2008

DECIDES

Article 1

To revise the License N° 101 L granted to Mr. CHHIN SONG by extending distribution area along National road N° 3 from Border of existing distribution area to Slakou bridge at Khum Beungtranh Southern, Samrong District, Takeo Province to allow Mr.

Chhin Song to supply electric power to consumers as show in the map in schedule1.

Article 2

The Schedule 1 of the license document N° 101 LD shall be replaced by new Schedule1 attached here with.

Article 3

This decision and attached revised schedule shall be considered as a part of the license documents N° 101 LD.

Article 4

The other contents and conditions of the license document N° 101 LD with its revisions shall remain in force.

Article 5

The decision shall come into force from the date of signing.

Article 6

The licensee shall send this decision to deposit additionally at the places, where the license document N° 101 LD has been deposited in order that the deposited license document N° 101 LD is in conformity with this decision.

SCHEDULE 1
AUTHORIZED DISTRIBUTION AREAS
AS AMMENDED IN SESSION OF EAC N°123 DATED February 15, 2008

1. The authorized distribution Areas, where Mr. Chhin Song has the right to provide electricity distribution and supply services are Khum Beungtranh Northern and Khum Beungtranh Southern , Samrong District , Takeo Province and Khum Porankrang, Borseth District, Kampong Speu Province .
2. The authorized distribution area is determined by “ the boundary maps 101 LD-Map- Chhin Song-Revision 3 2008 ” attached.
3. Under this license, if Mr. Chhing Song intends to request the extension or the additional distribution areas then Mr. Chhing Song shall prepare all necessary documents and submit to EAC in accordance with the EAC’s determination. After EAC authorized to extend or to add distribution area, this schedule 1 shall be revised and attached with that authorization.
