### DECISION ON TERMINATION OF THE CONSOLIDATED LICENSE No.135 L DATED JUNE 28, 2006 ISSUED TO Mrs. DIK RIN

#### ELECTRICITY AUTHORITY OF CAMBODIA

- In exercise of the powers conferred by Article 7 and 35 of the Electricity Law promulgated by the Royal Decree NS/RKM/0201/03, dated 02/02/2001.
- In accordance with License Documents N° 135 LD issued by Electricity Authority of Cambodia on June 28, 2006 to Mrs. DIK RIN
- In accordance with the request of Mrs. DIK RIN for transferring the right dated February 25, 2008.
- In accordance with the consultation with concerned parties and public, made from March 17, 2008 to March 31, 2008.
- In accordance with the decision of Electricity Authority of Cambodia's Session N° , dated , 2008.

#### DECIDES

##### Article 1

To terminate the right for providing electric power generation and distribution services at Phar Deumroka town, Khum Tang Daung, Bati District, Takeo Province and Khum Veal, Kongpisey District, Kampong Speu Province under the Consolidated license No.135 L dated June 28, 2006 issued to Mrs. Dik Rin.

Mrs. Dik Rin has requested to EAC to terminate her license and to transfer the above rights to Mr. Chhin Seng holding license No.064 L providing electric power services at Phsar Tram Khnar Town, Khum Sophy, Bati District, Takeo province and Khum Chung Ruk , Khum Snom Kropeu ,Kong Pisey District, Kampong Speu Province. Combination of Mrs. Dik Rin's authorized distribution area and Mr. Chhin Seng's authorized distribution area into one business is more efficient for technique and economy. EAC Accepts the reason and allows Mrs. Dik Rin to terminate the right in the license N.135 L and transfer to Mr. Chhin Seng .

##### Article 2

Mrs. Dik Rin shall have no right to provide the electric power services at Phar Deumroka town, Khum Tang Daung, Bati District, Takeo Province and Khum Veal, Kongpisey District, Kampong Speu Province as stated in the consolidated license No.135 L dated June 28, 2006 from the date Mrs. Dik Rin actually transfers the business of supply of electricity at above location to Mr. Chhin Seng.

Mrs. Dik Rin shall submit a copy of the contract of transfer of business to be executed with Mr. Chhin Seng to EAC for approval.

##### Article 3

The decision shall come into force from the date of actual transfer of business after approval of contract by EAC. Mrs. Dik Rin shall intimate EAC the date of actual transfer of business to Mr. Chin Seng .

##### Article 4

The EAC shall send this decision to deposit additionally at the places, where the license document No.135 LD has been deposited in order that the earlier deposited license document No.135 LD is no more valid as per this decision.
