- In exercise of the powers conferred by Article 7 and 35 of the Electricity Law promulgated by the Royal Decree No. NS/RKM/0201/03 dated 2 February 2001.
- Refer to the Consolidated License Document of Mr. Men Sambath No.156 LD dated February 7, 2007.
- Refer with the first revision decision on license document of Mr. Men Sambath N° 117-07-EAC dated August 31, 2007.
- In accordance with the application for extending distribution area of Mr. Men Sambath, dated February 12, 2008.
- In accordance with the consultation with concerned parties and public, made from ..., 2008 to ..., 2008.
- In accordance with the decision of Electricity Authority of Cambodia's Session N° ... dated ..., 2008.

DECIDES

Article 1

To revise License N° 156 L granted to Mr. Men Sambath to supply electric power at Khum Trapeang Kong, Samroang Tong District, Kampong Speu Province to give the right to licensee to extend the existing distribution area as show in the map attached.

Article 2

The Schedule 1 of the license documents N° 156 LD shall be replaced by new Schedule1 attached here with.

Article 3

This decision and the attached revised Schedule shall be considered as a part of the license documents N° 156 LD.

Article 4

The other contents and conditions of the license document N° 156 LD with its revisions shall remain in force.

Article 5

The decision shall come into force from the date of signing.

Article 6

The licensee shall send this decision to deposit additionally at the places, where the license document N° 156 LD has been deposited in order that the deposited license document N° 156 LD is in conformity with this decision.

AUTHORIZED DISTRIBUTION AREAS
AS AMMENDED IN SESSION OF EAC N°..... DATED, 2008

1. The authorized distribution Areas, where Mr. Men Sambath has the right to provide the electricity distribution and supply services at Khum Trapeang Kong, Samroang Tong District, Kampong Speu Province.
2. The authorized distribution Areas is terminated by the boundary map 156LD-map-Men Sambath-Revision1-2008 attached.

Under this license, if Mr. Men Sambath intends to request the extension or the additional distribution areas then Mr..Men Sambath shall prepare all necessary documents and submit to EAC in accordance with the EAC's determination.
